GROUNDS

- I. For that water is one kind of lifesaving material and river is big source of pure water and without pure water no one cannot be alive. So, it is related with right to life under Article 32 of the Constitution of Bangladesh. Moreover, contribution of river water in case of existing living things especially aquatic animals and balancing of the environment and ecosystem cannot be ignored. If the government authorities or respondents do not protect the Shitalakshya River from its pollution then aquatic animals and ecosystem would be destroyed.
- II. For that by act or omission of the respondents they have been continuously violating the provision of মহানগরী, বিভাগীয় শহর ও জেলা শহরের পৌর এলাকাসহ দেশের সকল পৌর এলাকার খেলার মাঠ উন্মুক্ত স্থান, উদ্যান এবং প্রকৃতিক জলাধার সংরক্ষণ আইন ২০০০ এবং পরিবেশ সংরক্ষণ আইন ১৯৯৫ (সংশোধনী ২০০০ এবং ২০০২) এবং পানি আইন ২০১৩. Due to ignorance of law pollution is growing everyday within Shiatalakkaha river at Narayangonj. So, a direction should be given upon the respondents to protect Shitalakshya River from pollution.
- III. For that failure of the respondents to stop pollution of the water of the Shitalakshya River by the industries are conflicting with the provisions of Article 18A and 32 of the Constitution of Bangladesh as such the inaction of the respondents are illegal, unlawful and intentional, hence the inaction of the respondents should be declared illegal and without lawful authority.
- IV. For that every year, a huge quantity of industrial untreated waste, rubbish and industrial chemical are mixing with the water of Shitalakshya River. For this reason, the water of Shitalakshya River has been polluting continuously and its effect fall on the environment as well as to health of the human being and other living things. So, a direction should be given upon the respondents to protect Shitalakshya River from pollution.
- V. For that the respondents have not been formed any monitoring team for observing the level of pollution of Shitalakshya River. As such a direction should be given upon the respondents to form a monitoring committee consisting of government officials for prevention of pollution of Shitalakshya River. Otherwise, it would

- not be possible to protect the biodiversity of the Shitalakshya River from the pollution.
- VI. For that as per Article 21 of the Constitution of Bangladesh the duty of every public servant is to perform public duties and to observe the constitution and the laws. According to the prevailing situation the provision of Article 21 of the Constitution of Bangladesh has been violated.
- VII. For that most of the respondents are the experienced public servant and very much aware of the rules and law of the land. That the duty and responsibility vested upon the respondents to serve the people but they have failed to follow the laws and rules to protect the interest of the citizen

Wherefore, it is most humbly prayed that your Lordships would graciously be pleased to issue: -

Rule Nisi calling upon Respondents to show cause as to why inaction of the respondents to stop pollution of water of Shitalakshya River, should not be declared illegal and without lawful authority and why a direction should not be given upon the respondents to take necessary steps to stop pollution of water of Shitalakshya River by way of effective measures and why a direction should not be given upon the respondents no. 8 to 125 to pay compensation for causing water pollution of the river Shitallakha at Narayngonj as per the assessment report of respondent no. 3 and 5 and why a direction should not be given upon the respondents no. 8 to 125 to stop operation of their industries if they fail to stop pollution of water of Shitalakkah river at Narayangonj,

AND

Why a direction should not be given upon the respondent no. 3-6 to seal/close all industrial waste discharge pipe line of the respondent no. 8-125 linked with Shitalakkha river at Narayangonj who are causing pollution of river.

b) Pending hearing of the Rule an order may be passed directing the respondents no.

7 to deploy police monitoring team at day and night time for continuous monitoring on the bank of Shitalakshya River in their respective areas so that no pollution of water of Shitalakshya River could be done caused by untreated waste, direct link of sewerage line to river, thrown of rubbish and waste materials in the river and release of chemical water from the industries mixed respondents no. 8 to 125 and also take legal action as per law against the violators who pollute water of Shitalakshya River and direct the respondent to file a compliance report within 2 weeks.

- c) Pending hearing of the rule direct the respondent no. 4 to from a monitoring committee consisting of officers of the relevant government authorities to monitor and ensure so that no one can discharge untreated waste, direct link of sewerage line to river, thrown of rubbish and waste materials in the river and release of chemical mixed water from the industries respondents no. 8 to 125 within the Shitalakshya River at Narayangonj and direct the respondent to file a compliance report within 2 weeks.
- d) Pending hearing of the rule direct the respondent no. 3 and 5 to assess the financial damage in terms of Taka due to pollution of water at Shitalakha river at Narayangonj by the respondents no. 8 to 125 and submit a report before the Hon'ble court within the 3 months.

Present Status

The case was filled and moved by Advocate Manzill Murshid, President, HRPB. After hearing the parties, the Hon'ble Court issued Rule Nisi upon the respondents and granted ad-interim order. The matter is pending before the Hon'ble High Court Division.
